Your safety is your own responsibility.

I accept that I will ride the course and use the fences entirely at my own risk. The North Northumberland Hunt Supporters/College Valley North Northumberland Hunt/Ford & Etal Estates DO NOT accept responsibility for any accident or damage to you, your horse, your vehicle or any companions whatsoever and however caused. It is a condition of the use of the course that this is understood and by signing this Disclaimer you acknowledge this.

The fences are of varied heights, nature and levels of difficulty. The decision to jump is ultimately the responsibility of the rider (or parent/guardian if under 10). The rider or parent/guardian alone has to decide on the limits of their horse or pony and **it is essential that you inspect each fence before you jump to ensure it is safe for you.**

- ✓ **Regulation Hats (& Body Protectors)** must be worn at all times when mounted. While no actual inspections will be made, the following are up-to-date 2024 accepted Hat standards according to The Pony Club: Snell E2016 & 2021 with the official Snell label & number, PAS 015: 2011 with BSI Kitemark or Inspec IC Mark, (BS) EN 1384:2023 with BSI Kitemark or Inspec Mark, VG1 with BSI Kitemark or Inspec IC Mark, ASTM-F1163 2015 & 2023 with SEI Mark and AS/NZS 3838 2006 with SAI Global Mark.
- ✓ **Regulation Body Protectors** – to comply with the 2018 Level 3 standard Blue on Black label.
- ✓ It is compulsory that **all riders or groups are accompanied**. Children under 10 must be accompanied by a parent or guardian. One person in the group must carry a **mobile phone**.
- ✓ Any damage must be reported to a NNHSC official before leaving the ground.
- ✓ Following any serious incident requiring **professional medical or veterinary** intervention on the course, **a NNHSC official must be notified**:
